Better Access

Everyone deserves quality healthcare. Yet historically marginalized populations, including those involved in the legal system, have had limited healthcare access, both inside facilities and in the community where they're released.

MEDICAID INMATE EXCLUSION POLICY / 1115 WAIVER

The Medicaid Inmate Exclusion Policy prevents state Medicaid agencies from providing benefits to correctional facility residents while incarcerated and in the period before their release. We partnered with one state on applying for an 1115 waiver to include a pre-release request up to 90 days prior to community reentry and ensure access to care providers and medications upon their release.

The waiver aims to improve continuity of care after release; address racial and health inequities in youth and adult systems; leverage Medicaid financing for correctional healthcare services; and improve the public health response.

BEHAVIORAL HEALTH FOR JUSTICE-INVOLVED INDIVIDUALS (BH-JI)

In 2019, ForHealth Consulting, along with a variety of community partners and sponsoring agencies, collaborated with the Massachusetts Medicaid (MassHealth) program in the development of the MassHealth Behavioral Health Supports for Justice-Involved Individuals (BH-JI) intervention. Using in-reach pre-release from correctional institutions and navigator services in the community post-release, this initiative worked to improve health outcomes, reduce fatal overdoses, and demonstrate efficient healthcare utilization for justice-involved individuals. Since inception, the program has enrolled and positively impacted 3,900+ individuals.

ACADEMIC CONSORTIUM ON CRIMINAL JUSTICE HEALTH

The Academic Consortium on Criminal Justice Health (ACCJH) advances health research, training, and care for justice-involved populations. ACCJH members benefit from an academic community that conducts breakthrough research in correctional

healthcare, and develops and promotes a broader view of the relationships between community and justice-involved healthcare.

The annual ACCJH Conference is an interdisciplinary event that highlights emerging research and policy across the justice field and brings together researchers, clinicians, public health experts, justice partners, and policymakers. ACCJH aims to improve evidence-based practices and policies to advance the health of justice-involved populations.
